Council Updates

Council Discusses the Proposed Fiscal Year 2024 Budget

City Manager David Gaines presented his [budget for fiscal year 2024](#) to the City Council on July 31. The City Council heard from various department directors, the CFO, and the city manager during a budget retreat on August 3 and August 4 at the Addison Conference Centre and prior to the August 8 City Council meeting.

The proposed fiscal year 2024 budget has no increase to the Town's tax rate of \$0.609822. On an annual basis, the Dallas Central Appraisal District provides the Town with a certified tax roll of all properties inside Addison's city limits. The certified taxable value for fiscal year 2024 is \$6,160,034,059 equating to an increase of 9.4% from the previous year. Included in the certified taxable values are \$114,459,940 in new properties added to the tax roll between January 1 and December 31, 2022. The average taxable value for a single-family home in Addison has increased 11.4% to \$426,498.

There will be a public hearing on the budget and tax rate during a Special City Council Meeting on September 5 and another during the regularly scheduled meeting on September 12. Meeting agendas are posted [on the Town's website](#) three days prior to the meeting.

[Soulful Street Bites Expands to Offer Dine-In Service](#)



The City Council approved a Special Use Permit (SUP) for a full-service restaurant specializing in New Orleans-inspired soul food at its August 8 meeting. Soulful Street Bites began as a food truck and expanded to an 800-square-foot storefront at 16601 Addison Road, Suite 110 for catering and takeout only. With the approval of this SUP, owners Michael and Elizabeth Smith are expanding their current space to 2,445 square feet so they can offer dine-in service.

Vital Skills Training Center to Offer Training for Healthcare Professionals



Quality Training for Future Healthcare Professionals



At its August 8 meeting, the City Council approved a Special Use Permit (SUP) for Vital Skills Training Center at 4851 Keller Springs Road, Suite 203. Addison's zoning ordinance allows educational institutions through the approval of an SUP within any zoning district. Vital Skills offers a training program to provide employment skills and certification preparedness for future nursing assistants, healthcare professionals and the general public who wish to be certified in basic life support (BLS)/cardiopulmonary resuscitation (CPR).

Council Authorizes Issuance of Bonds

At its August 8 meeting, the Council passed two Resolutions authorizing the issuance of bonds for proposed streets, infrastructure, parks, and building updates. Council approved the sale of \$4.6 million of Certificates of Obligation to be used for the following purposes:

1. \$2,050,000 for the purpose of public infrastructure improvements in Vitruvian Park. The Town has an investment commitment of approximately \$50M and, to date, has invested approximately \$37M in public infrastructure in Vitruvian Park. After this proposed issuance, approximately \$11M of investment will remain.
2. \$2,550,000 for the purpose of funding planned roadway capital improvements projects related to the Addison Airport, serviced by revenue from the Addison Airport, including reconstruction of Jimmy Doolittle Drive and the east side airport service road.

The bonds were issued for 20 years with an interest rate of 3.77% and a \$206,604 premium resulting in a lower issuance principal amount of \$4,355,000. After payment of bond issuance costs, the Town will receive over \$4.5 million for these projects.

Council also approved the issuance of General Obligation Bonds totaling \$5 million for the following projects approved by voters during the 2019 Bond Election:

1. \$900,000 for the reconstruction design of Monfort Drive
2. \$4.1 million for the reconstruction design of Quorum Drive

Design contracts for both projects have been approved by the Council.

These bonds were issued for 20 years with an interest rate of 3.79% and a \$198,619.30 premium resulting in a lower issuance principal amount of \$4,865,000. After payment of bond issuance costs, the Town will still receive the \$5,000,000 needed for these projects.

The financial impacts of the General Obligation bond issuance were less than the projections included in the materials provided to the public as part of the 2019 Bond Election process. Addison is one of only 11 cities in Texas with a AAA with both Moody's and S&P.

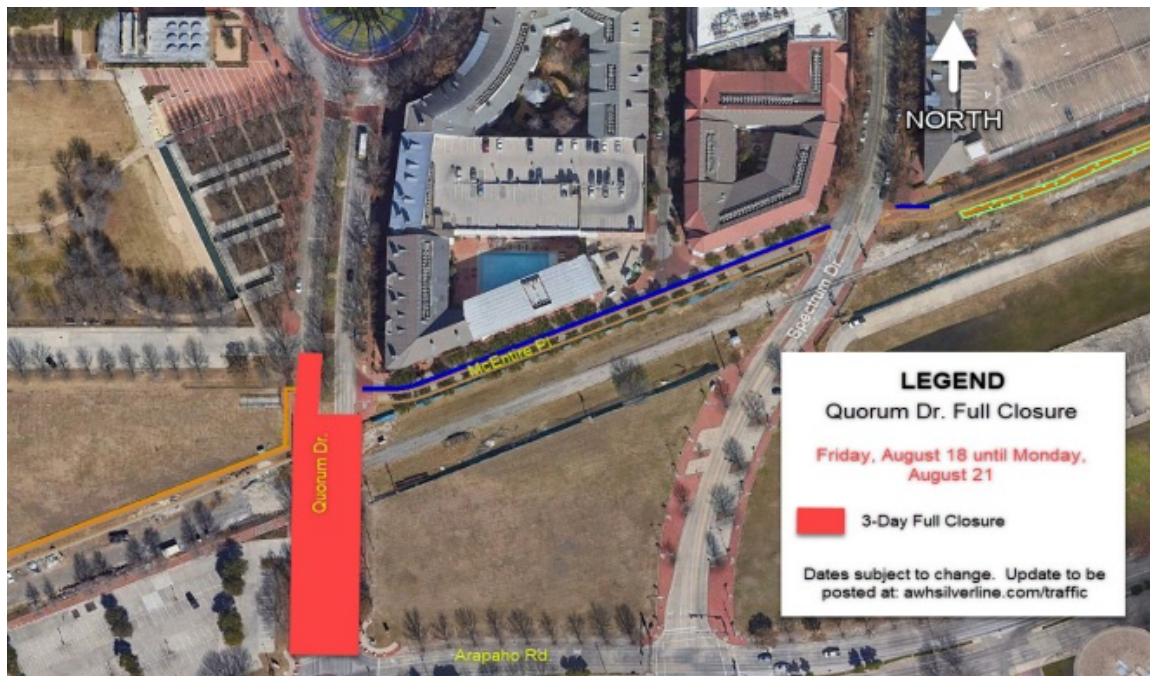
- Case 1877-Z/Trammell Crow Mixed Use. Hold a public hearing, present, discuss, and consider action on a request to rezone 10.1± acres generally located at the southeast corner of Belt Line Road and Surveyor Boulevard, from Planned Development (PD) to the Belt Line District, to allow a mixed use development comprised of multifamily residential and live/work dwelling units (apartment complex), townhomes (single-family unit, attached), restaurant and retail uses, and associated private open space and common areas, through the approval of a concept plan and associated major waiver requests related to block length, 4th floor building façade setback, freestanding restaurant building height, building entry and parking structure design requirements.
- Case 1884-SUP/4021 Belt Line Road, Suite 107 (Luxe). Hold a public hearing, present, discuss, and consider action on a request for a Special Use Permit (SUP)

for property located at 4021 Belt Line Road, Suite 107, that is currently zoned Planned Development (PD), through Ordinance No. O17-07, to allow a restaurant with the sale of alcoholic beverages for on-premises consumption.

- Case 1889-SUP/14960 Landmark Boulevard (Holiday Inn Express & Suites). Hold a public hearing, present, discuss, and consider action on a request to amend Special Use Permit (SUP), Ordinance No. O14-022, for property located at 14960 Landmark Boulevard, that is currently zoned Commercial-1 (C-1), to allow the sale of beer and wine for off-premises consumption.
- Case 1890-Z/4900 Arapaho Road (One Addison Place PD Amendment). Hold a public hearing, present, discuss, and consider action on a request to amend the permitted uses and development plans for Planned Development (PD) Ordinance No. O20-53, for a 0.57± acre property located at 4900 Arapaho Road, to allow multifamily residential use, not to exceed one dwelling unit, within a 5-story commercial building.

Construction Corner

Quorum Drive Closed at Rail Crossing August 18 - 21



Archer Western Herzog, DART's contractor for the Silver Line, is planning to completely close Quorum Drive between Arapaho Road and Festival Way from Friday, August 18 at 9am until Monday, August 21 at 3:30pm. The closure is needed to demolish the temporary railroad crossing and install ballast, track ties, and rail. Crews will reopen the lanes as soon as the work is completed. Detour signs will be posted, but drivers are encouraged to consider alternate routes while this work is taking place.

Midway Road Update



Work on the Midway Road Revitalization Project continues. Next up is the placement of the main lane paving on the west side of the northern section of Midway Road from just north of the Dooley/Boyington intersection southward to Lindbergh Drive. The concrete placement will begin on Friday, August 11 and is anticipated to take 5-7 working days to complete. This work will require some temporary lane closures along the route to allow concrete trucks to access the paving equipment.

Final sections of the main lane pavement are being completed along the east side of Midway Road from Proton Drive to Belt Line Road. Additionally, franchised and private utility adjustments, sidewalks, SidePath Trail, and accessible ramp construction continues along Midway Road from Spring Valley Road to Belt Line Road. New Traffic Signal construction is underway at several intersections along this corridor, and new street lighting is being installed along the entire corridor.

Installation has begun of the new waterline under the DART right-of-way by boring beneath the numerous utilities, bridges and other improvements in this area. It is anticipated to be completed by early September.

Drivers should pay close attention to the traffic control and lane assignments in this area and observe the location of signal heads and directional signage at the intersections.
